RELEASE OF LIABILITY, HOLD HARMLESS AGREEMENT AND ASSUMPTION OF RISK

In consideration for the privilege of participation in Travis Outdoor Recreation, and all other persons or entities acting in any capacity on its behalf (hereinafter referred to as "Outdoor Recreation"), I hereby agree to release and discharge Outdoor Recreation, on behalf of myself, my heirs, assigns, personal representative and estate as follows:

1. I understand and acknowledge that the activity I am about to engage in bears known risks and unanticipated risks that could result in injury, death, illness, disease emotional distress, or damage to myself, to property or to third parties. Intl_____
2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary. **No one** is forcing me to participate and I elect to participate in spite of the risks. Intl_____
3. I hereby voluntarily release, forever discharge, and agree to hold harmless and indemnify Outdoor Recreation from any and all liability, claims, demands **and** actions which are related to or arise out of negligent acts **or** omissions of Outdoor Recreation. Intl_____
4. I understand that participation in the program may subject me to potentially hazardous outings such as, but not limited to, mountaineering, white water rafting, surfing, hiking, Nordic & alpine skiing, biking and other physical and strenuous outdoor activities. Intl_____
5. I am expected to engage in only those activities that I am physically capable of safely accomplishing. Intl_____
6. I understand that water activities and instructions may be held at the base pool or local lakes and rivers without the supervision of a lifeguard. Intl_____
7. There will be no consumption of alcohol on any OAP trip in any capacity whatsoever due to the fact that the activities may subject the participant to potential hazards. Intl_____
8. If I chose on my own accord to either arrive or leave any OAP activity in a privately owned vehicle, I am acting outside the scope of responsibility of the OAP activity involved and neither the OAP or Travis Air Force Base can be held responsible for any injury or damage done to myself or my equipment while in the privately owned vehicle. Intl_____
9. Should Outdoor Recreation, or anyone on its behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to bear the costs of such injury or damage. Intl_____
10. I certify that I have health, accident and liability insurance to cover any bodily injury OR property damage I may suffer while participating in this event, or else I agree to bear the cost of such injury or damage without seeking compensation from Outdoor Recreation, Travis AFB, or the United States Air Force. Intl_____

11. I hereby release, waive, and relinquish all claims and legal actions from personal injury, wrongful death, or property damage against the U.S. Department of the Interior-Bureau of Reclamation ("U.S. Government"), State of California, its permittees arising as a result of my participation in the Whitewater River trips or any other activity described herein, my use of permittee's equipment, or any activities incidental thereto including rescue activities; this release applies even if permittee and/or state and/or U.S. Government are negligent or otherwise at fault. I also agree to protect, hold harmless, defend and indemnify permittee, state, and U.S. Government and hold them harmless from all claims and legal actions for personal injury, death, or property damage arising from my conduct; these indemnities apply, even if permittee, State, and U.S. Government are negligent or otherwise at fault. Intl_____

12. I hereby voluntarily release the rights for all photography and/or video captured while participating in Outdoor Recreation activities. I also grant permission to Travis Outdoor Recreation and the 60 Force Support Squadron Marketing Departments to use such images and video clips for program marketing; in accordance to Air Force Marketing and Publishing Instructions. Intl_____

“BY SIGNING THIS DOCUMENT, I ACKNOWLEDGE THAT IF ANYONE IS HURT OR PROPERTY IS DAMAGED DURING MY PARTICIPATION IN THIS ACTIVITY, I WILL HAVE NO RIGHT TO MAKE A CLAIM OR FILE A LAWSUIT AGAINST OUTDOOR RECREATION, ITS AGENTS, OWNERS, OFFICERS, EMPLOYEES, OR ANY OTHER PERSON OR ENTITY ACTING IN ANY CAPACITY ON ITS BEHALF EVEN IF THEY OR ANY OF THEM NEGLIGENTLY CAUSED SUCH INJURY OR DAMAGE. MY PARTICIPATION IS VOLUNTARY AND I ASSUME SUCH RISKS WILLINGLY AND KNOWINGLY.”
